

**30 Month Deferred Interest, 3.5% Minimum Payments Financing:** No money down except the equivalent of your sales tax and delivery charge. A \$1,500 minimum purchase is required for 30 month financing. If the balance is not paid in full within the promotional term length or if you fail to make any payment when due, regular credit terms will apply and interest will be imposed from the end of the promotional period at the standard, variable purchase APR of 29.99%, based on the Prime Rate.
